Memorandum of Association

1. The name of the Society is "Shramik Bharti".
2. The registered office of the society shall be situated in Uttar Pradesh at 104-A/23, Rambagh, Kanpur.
3. The objects with which the society is formed are:-
 - i) To promote people's participation and community action for social, economic and cultural development of poor people;
 - ii) To organize and stimulate adult and non-formal education of urban and rural poor;
 - iii) To organize people's programmes in different developmental sectors, e.g. health, education, employment, child welfare, etc.;
 - iv) To promote women's development through their education and action on their rights and privileges;
 - v) To promote, organize and conduct research in people's participation and action for development;
 - vi) To promote continuing and liberating education of adults, particularly the under privileged sections of different societies;
 - vii) To establish and maintain libraries and documentation centres;
 - viii) To organize seminars, workshops, conferences, exchange visits, study tours etc.;
 - ix) To organize, sponsor and support training programmes related aspects;
 - x) To publish books, papers, monographs and other materials for furtherance of the society;
 - xi) To support, fund and collaborate with similar projects being conducted by other similar institutions;

- xii) To offer fellowships, scholarships, prizes, stipends; etc. in furtherance of the objects of the society.
- xiii) To issue appeals and applications for money and funds in furtherance of the said objects and to accept gifts, grants, donations and subscriptions of cash and securities and of any property movable or immovable;
- xiv) To invest and deal with funds and moneys of the Society and to vary, alter or to transpose such investments from time to time;
- xv) To purchase or otherwise acquire or take on lease or hire temporarily or permanently, any movable or immovable property necessary or convenient for the furtherance of the objects of the Society;
- xvi) To sell mortgage, lease, exchange and otherwise transfer or dispose of or deal with all or any property movable or immovable, of the Society for the furtherance of the objects of the Society; *after having* ^{had} prior permission from the court of law. *had*
- xvii) To construct, maintain, alter, improve or develop any buildings or works necessary or convenient for the purposes of the Society;
- xviii) To create administrative, academic and other positions under the Society and make appointments there to as per the by-laws of the Society;
- xix) To borrow or raise funds on mortgage, promissory notes or other securities funded or based upon all or any securities;
- xx) To make rules and bye-laws for the conduct of the affairs of the Society and add to, amend, vary or rescind them from time to time.
- xxi) To do, or get done, all such other lawful things as are conducive or incidental to the attainment of the said objects.
- xxii) All income of the Society shall be utilised towards the promotion of aims and objectives of the Society.
